# Award Criteria

While the overall contributions to hospital medicine are the overriding criteria, some or all of the following elements may be considered in the selection process for this award:

- Innovations or contributions at their hospital or in their hospitalist group
- Leadership
- Outstanding contributions to patient care
- Excellence in education
- Professionalism
- Excellence in practice management
- Organizational activities

#### Eligibility

Nominee must be an SHM member who is not a physician. Nominee may be a physician assistant, nurse practitioner, registered nurse, pharmacist, administrator, case manager, or any other non-physician member of SHM. Any current SHM member other than XXX SHM Chapter leaders are eligible for nomination. Awardees may be self-nominated.

#### **Resident of the Year in Hospital Medicine**

The future of hospital medicine is our trainees. The XXX Chapter of the Society of Hospital Medicine (SHM) recognizes those individuals through its annual Award for Resident of the Year in Hospital Medicine

#### Award Criteria

While the overall contributions to hospital medicine are the overriding criteria, some or all of the following elements may be considered in the selection process for this award:

- Professionalism
- Dedication to teaching
- Involvement in hospital medicine research

## Eligibility

Nominee must be a resident physician in good standing with an ACGME accredited residency program at the time of the awards ceremony. Awardees may be self-nominated.
